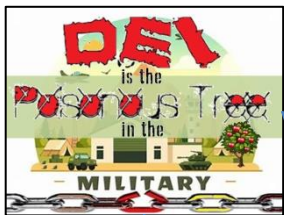

← 20230118 MAJ sends Forbes to eCDBHE (APA 3.06)

← 20230112 COL launched clandestine inv. (MWPA)

← 20230110 CSM Prewitt failed to get Forbes toxic admission

← 20221219 COL Brunson removes Forbes from all duties (MWPA)

← 20221219 SFC Forbes contacts Hon. Hudson, NC 9th

← 20221219 USASOC responds with lack of directives and notifies SFC's CoC

← 20221216 SFC Forbes 'reaches out' for directives from 1SFC and USASOC

← 20221214 SFC Forbes reports assault to Provost Martial Office (Military Police)

← 20221213 SFC Forbes reports assault to 1SFC IG

← 20221212 BN CSM Emekaekwue assaults SFC Forbes in front of BN formation (Art. 128, MCM)

← 20221212 SFC Forbes is permitted to put out "national security commercial" in morning formation

← 20221209 Non-Public Affairs Officer publishes Facebook Christmas party phones pic in our facility (AR 360-1)

← 20221208 CPT Korista removes signs prohibiting phones in our classified facility. (USASOC 25-2-RAR, video proof)

← 20221207 SFC Forbes performs appointed duty and puts up signs to impede flow of phones in facility due to OPORD

← 20221202 SFC Forbes immediately emails 1SFC IG and receives their instructions of "reaching out to your HPW team"

← 20221202 COL Brunson Orders implementation of falsified HPW OPORD as BDE CDR (Article 107 & all referenced on 20221129)

← 20221130 COL Brunson asks SFC Forbes, "Why do you want to die on this hill?" (MWPA)

← 20221130 MAJ Racaza verbally complains of disrespect to COL (SFC protected by Article 89, Special Defense of MCM if argued it in fair venue)

← 20221213 SFC Forbes follows IG guidance and requests the required missing "statutory support and scope" of SDI 2.0

← 20221130 SFC Forbes calls and emails 1SFC IG and immediately follows instructions to "ask the source"

20221129 1649 MAJ Racaza supports SDI 2.0, as Command Operational Psychologist (all in below two entries)

20221129 1648 Racaza (as a civilian corporate facilitator) ordered SDI 2.0 (all referenced below plus APA 1.03, 2.01, 2.04, 3.04, 3.05, 3.08, 3.10, 3.11 and more)

20221129 1625 COL Brunson Orders SDI 2.0 as BDE CDR (5 USC § 552a, 32 CFR Part 219.116, 45 CFR § 46, DoD 5400.11-R, EO M-10-22 & 23)
